Your weekly Housing Benefit award will be calculated by taking 65% of your Excess Income (£75) from your weekly eligible rent amount. e.g. weekly eligible rent is £100 and your excess income is £75. Housing Benefit is £100.00 minus (65% of £75). So this is £100 minus £48.75 = £51.25 per week.
