Parallelism in relation to words, particularly when it is a least three words, often relates to items in a list or series, which will be joined by coordinating conjunctions (for, and, but, yet, so, or, nor) and correlative conjunctions (both/and; neither/nor).

Parallelism Grammar Rules (Parallel Structure)

Correlative conjunctions require parallel structure. Either... or, neither... nor, and not only... but also require special attention when you are proofreading for parallelism. Be sure that you have equal grammatical units after both parts. For example, you can have two main clauses like this:

Parallel structure should be used when you connect clauses with a coordinating conjunction such as: for, and, nor, or, but, so, or yet. Some examples of this include: Correct: Every morning, we make our bed, eat breakfast and feed the dog. Incorrect: Every morning, we make our bed, eating breakfast and feed the dog.

When using correlative conjunctions, be sure to keep parallel structure intact. Equal grammatical units need to be incorporated into the entire sentence. For example: Not only did Mary grill burgers for Michael, but she also fixed a steak for her dog, Vinny.
